About pledges

1. A pledge is a commitment to pay a certain periodic sum (whether monthly, quarterly or annually) over a period of years. Its value to the Campaign is that it enables us to plan for income to the Campaign with a higher degree of certainty, unlike regular Gift Aid payments which can be cancelled at any time.

2. Should your circumstances change, such that the amount of income and/or Capital Gains Tax you pay in each tax year is no longer equal to or more than the amount of tax that all charities you donate to will reclaim on your gifts for that tax year, please let us know so that we do not attempt to reclaim tax on your gift. In such a situation it is of course very likely that you would be unable to continue payments. If that is the case please let us know and we will obviously not expect you to continue with the pledge and offer grateful thanks for your support.

3. If you pay income tax at the higher or additional rate you can claim the difference between the higher and basic rate on your donation. To receive the additional tax relief you must include all your Gift Aid donations on your Self Assessment tax return or ask your employer (or HM Revenue and Customs) to adjust your tax code.
